Dear members of Slovene club of retrievers and all interested public!

I thought long and substantially before I accepted a decision, that I resign as a member from Slovene club of retrievers (in continuation SKR). There is number of reasons, but I will list only two of them Ë most substantial:

- Foundation of cynology is breeding of purebreed dogs, which is determinated with regulations of KZS (Cynologic association of Slovenia) and FCI (International cynologic association). I don't like and I don't want to be the member of organization, where some members of bodies and visible members of organization of Slovene club of retrievers (the international cynologic judges and breeders), break breeding regulations of KZS and FCI.
- Management of SKR divvies members on »ours« and »yours« (the violation of third point of second paragraph of Societies Act).

I was active always on welfare of club and for positive propaganda of Slovene breeding of retrievers. High moral and ethical measures are requirement for credible and reliable breeding of healthy typical representatives of their breed. For that reason only acceptable breeding for me is where unconditionally breeder always works to welfare of dog and breed. Everything must be in accordance with valid regulations and legislation. With people who don't work by valid rules, moral principles and legislation, I not want to agree and I am not able to cooperate with them.

When current policy and vision of SKR will change, we can speak about repeated cooperation.
